NOTICE

Sub: Schedule for New registration, Up-gradation of seats & MOP up counselling (for M group) to fill up vacant seats for admission in the Govt. ITIs & Govt. ITIs running under PTP-2025.

The Mop-up SPOT counselling in the **vacant seats** of M group trades will be conducted as per following schedule:

Sl no.	Event	Date	Candidate's role
01.	Publication of seat Matrix (for vacant seats & few newly affiliated seats.)	13/10/2025	Candidate can view the ITI wise vacancies.
02.	New registration window will remain open upto 14/10/2025 up to (3 P.M.) to collect fresh application (only for those applicants who had not applied earlier)	12/10/2025 to 14/10/2025 up to (3 P.M.)	Subsidiary merit list will be published for such candidates. Already registered candidates need not require to apply.
03.	Online choice filling for up-gradation of already admitted candidates	14/10/2025 (from 10.00 A.M to 4.00 P.M)	Willing eligible students will provide their single choice of institute and trade where he/she wants to up-grade.
04.	Vacancy declaration	14/10/2025 (Evening)	
05.	Mop up SPOT counseling for fresh applicants & non admitted candidates.	15/10/2025 At 12.00 Noon	Any non-admitted candidate having valid rank in the first merit list as well as in the extended merit list, are eligible to take part in the Mop-Up Round.
06.	Starting of class	16/10/2025	

Guideline for the ITI on 14/10/2025 (Up-gradation round):

As per the notification published earlier, an **Upgrade Round** will be held for all **admitted candidates** against available vacancies. **The Upgrade Round will be held in all Govt. ITI/ Govt. ITI running under PTP based on the merit list.**

The guidelines for allotment and admission of the students in Upgrade Round are as follows:—

- The portal for Upgrade Round is [**https://scvtwb.in/**](https://scvtwb.in/)
- The students who got admitted in different Govt./PTP ITIs during previous counselling, but didn't get their 1st choice, are only eligible to take part in this Upgrade Round.
- **Willing eligible students will provide their single choice of institute and trade on 14th October, 2025** based on the vacancy to be declared on 13th Octoberber, 2025. **The portal will remain open from 10.00 A.M to 4.00 P.M for receiving such application.**
- **The result of Upgrade Round will be available on late evening of 14/10/2025.**
- **No physical verification of the eligibility criteria of such upgraded students is required to be made at the institute level where up-gradation has been made, since such activities have already been done against such students.**
- **No payment towards admission and tuition fees need to be collected from such students except up-gradation from Govt. Quota to IMC quota and IMC Non Engg trade to IMC Engg trade.**
- **The students whose seats will be upgraded, shall be deemed to have admitted in the allotted institute and trade. In case of allotment of upgraded seat, the presently allotted seat will get cancelled automatically. The concerned students will have to start their classes in the new institute and trade.**
- The students whose seats will not upgrade, shall have to continue their classes in the present institute and branch.
- **No action at institute level is required for this Upgrade Round.**

Guideline for the ITI on 15/10/2025 (Mop-up round):

A final **Mop-Up Round** will also be held on **15th October, 2025**. The eligibility criteria along with guidelines for allotment and admission of the students in **Mop-Up Round** are as follows:—

- The portal for **Mop-Up Round** is <https://scvtwb.in/>
- Institute-wise and Trade-wise Vacancy List will be available on the aforesaid website, against which **Mop-Up Round** will be conducted.
- Any **non-admitted** candidate, having valid rank in the first merit list as well as in the extended merit list, are eligible to take part in the **Mop-Up Round**.
- In addition to the aforesaid candidates, fresh application will also be collected from the willing eligible candidates. For the purpose, the application portal will remain open from 12/10/2025 to 14/10/2025(up to 3.00 P.M).
- Based on the application so received, the **3rd Extended Merit List** will be published.
- Willing candidates have to **appear physically** for **Mop-Up Round** in the institute of their choice **within 12.00 Noon on 15th October, 2025**.
- The candidates, who will report within 12 Noon on the date of **Mop-Up Round** on 15/10/2025, may be issued with a TOKEN and they should be queued in accordance with their General Rank.
- A slip should be provided to all reported candidates containing the following information and get it signed by them for the purpose of documentation and written evidence of their submission of preferred choices of trade/discipline.
 - Date of Counselling
 - Name of the Candidate
 - General Rank
 - Mobile Number
 - Name of the Institute where Reported
 - Choices of Branch / Discipline as per their preference
 - Signature with Date and Time
- The candidates may thereafter be called for counselling one-by-one in accordance with their General Rank.
- **The students belonging to Reserved Category may be offered category/quota seats, if available, upon verification of all supporting documents.**
- Upon providing the registered mobile number of the candidates in the portal, all details provided by the candidates during application will be displayed for verification purposes.
- **Upon successful verification of all eligibility criteria of an applicant with respect to**

the data available on the portal, he/she may be allotted against a seat in his/her preferred trade in accordance with the available vacancy.

- The amount of admission and tuition fee has to be collected through **GRIPS portal in ONLINE MODE** at the time of taking admission. **The candidates will be advised to bring with them a smart mobile phone.**
- The candidates have to report at the institute with the following documents in **ORIGINAL** along with a set of photocopies of the same
 - Rank Card
 - Admit Card of Madhyamik or Equivalent Examination
 - Marksheets of Qualifying Examination
 - Caste Certificate (if applicable)
- Counselling and admission in **Mop-Up Round** will be closed as soon as the vacant seats of the concerned institute are filled up. No further counselling will take place thereafter.
